WHEREAS, submitted for the consideration of this Honorable Body is a Letter from the Office of the Provincial Governor endorsing the request of the City Government of Ilagan, Isabela that the Provincial Road traversing the Development Bank of the Philippines (DBP) down to the Petron Gasoline Station in Barangay Osmeña, City of Ilagan, Isabela be converted to a City Road;

WHEREAS, this Honorable Body recognizes that the provincial road connecting the DBP and Petron Gasoline Station links intricate road systems and vital government institutions in the City of Ilagan, Isabela. As such, the management and maintenance thereof are better left to the supervision of the City Government of Ilagan, Isabela which, as stated in the previous paragraph, have good understanding of the road conditions and traffic circumstances in their territorial jurisdiction;

WHEREAS, this Honorable Body further recognizes that the City Government of Ilagan, Isabela possesses ample resources and displayed willingness to maintain the good condition of such road. As such, it determines that such conversion will lead to the better preservation and utilization of such road to the benefit of the riding public;

WHEREAS, acknowledging the authority of the Department of Public Works and Highways to classify roads and highways, and to provide and authorize the conversion of roads and highways from one category to another, this Honorable Body hereby endorses to the DPWH Secretary, Honorable Roger G. Mercado, the conversion of the herein provided provincial road to a city road;

WHEREFORE, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
